- Bids will be opened July 25, 2012. Successful bidder notified July 25, 2012.
- All bids must be submitted on this form.
- Acceptable forms of payment include: cash, cashiers check made payable to Fremont County Government. If submitting a personal check, funds will be validated before the vehicle and title are released. **Payment must be received within 24 hours of notification of successful bid.** If payment is not received, the vehicle will be offered to the next highest bidder.
- Descriptions are believed to be correct, but are not guaranteed. Fremont County Government will not be held responsible for advertising errors or omissions. In addition, **all vehicles are sold AS IS** with no implied or expressed warranty. All sale items are being offered as-is, where-is, with all defects, and without any warranties. Service records are available for viewing at 1578 Dubois Highway in Lander, Wyoming or at the Riverton Shop located at 4441 Skylane Avenue in Riverton, Wyoming. Copies may be secured for a fee of .15¢ per copy.
