
At their July 18, 2016 Budget Hearing and regular meeting, the Fremont County School District No. 24 Board of Trustees voted to levy the following mills:

BUDGET APPROPRIATION

WHEREAS, by the 15th of May, 2016, the CFO/Business Manager/Budget Officer presented to the Board of Trustees of Fremont County School District No. 24, a tentative budget for the fiscal year ending June 30, 2017, and

WHEREAS, a summary of such budget was entered into the Board minutes, and prior notice of a public hearing on such budget together with said summary was published in the Riverton Ranger, a newspaper having general circulation in the county in which the district is located, on the 6th day of July, 2016, and the Shoshoni Pioneer, on the 7th day of July, 2016, and

WHEREAS, a public hearing was held concerning such budget on Monday, July 18th at 5:30 p.m., at which time all interested parties were given an opportunity to be heard.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Fremont County School District No. 24 that such budget, as revised, if applicable, is hereby adopted and, subject to future amendment, in effect for the fiscal year ending June 30, 2017.

BE IT FURTHER RESOLVED that the following appropriations are made as of and for the fiscal year ending June 30, 2017, and that those respective expenditures applicable to each department and fund shall be limited to the amounts hereby appropriated, subject to future amendment.
